- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The wetland addressed in this form was determined to be isolated non-jurisdictional. Although in itself the wetlands meet the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, connection to another water of the U.S. could not be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetlands are retained within the wetland boundaries and percolate to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps do not depict any linear features (i.e. blue lines) on the property. Also present on site is an upland excavated ditch determined drain only uplands and an upland excavated pond determined not to be an impoundment of waters**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Data sheets submitted by Earthwookds show the majority of the project areas is upland. The upland areas lacked hydrology and. Adjacent JD mapped the area as uplands .
