- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This form addresses an 94.89 acre tract located entirely within uplands. Potential aquatic resources were examined during the site visit conducted on 30 March 2018 and follow up visit on May 23, 2018. Hydric soils or indicators of hydrology were observed on site which are typical of agricultural fields. Thirteen (13) drainage ditches are located on-site. These features are determined to have been excavated out of uplands and to drain only uplands. USGS topographic maps depict a blue line in the northern portion of the site but it was not observed in the field but was determined to be an upland excavated non-jurisdictional ditch. Additionally, USGS maps depict the site as agricultural fields and the site is depicted as uplands on NWIs. Aerial photographs and photos taken on-site and submitted by the consultant depict these features as upland excavated agricultural drainage ditches. Additionally, a single upland excavated non-jurisdictional pond is located onsite (0.78 acres) with no jurisdictional features and is not connected to other WOUS..**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses an 94.89 acre tract located entirely within uplands. Potential aquatic resources were examined during the site visit conducted on 30 March 2018 and a follow up visit on May 23, 2018. Hydric soils or indicators of hydrology were observed on site which are typical of agricultural fields. Thirteen (13) drainage ditches are located on-site (see typical photo of ditches below). These features are determined to have been excavated out of uplands and to drain only uplands. USGS topographic maps depict a blue line in the northern portion of the site but it was not observed in the field but was determined to be an upland excavated non-jurisdictional ditch. Additionally, USGS maps depict the site as agricultural fields and the site is depicted as uplands on NWIs. Aerial photographs and photos taken on-site and submitted by the consultant depict these features as upland excavated agricultural drainage ditches. Additionally, a single upland excavated non-jurisdictional pond is located onsite (0.78 acres) with no jurisdictional features and is not connected to other WOUS.

This site was assessed on a single basis form.
