C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This review is for a 2.97 acre parcel of land located south of and adjacent to Hardee Ferry Road in the Conway Township of Horry County. A site visit was conducted on May 16, 2018 in response to a jurisdictional determination request. The site is comprised of Eulonia and Wahee soils, which are hydric for their mapped units in Horry County. Marginal hydrophytic vegetation was observed during the site audit, as well as a large percentage of upland species. However, hydrology was not observed anywhere onsite (surface or subsurface) after 0.02" of rain the previous night. Soils were dry, friable, and fell apart / crumbled out of the auger with each sample. All indicators (USGS Topo, geomorphic identifiers, field observation) point to the site's historical use of agriculture, transitioning into various stages of succession, forested land, but void of wetlands or other WOUS.

Two ditches are located onsite and were determined to be excavated out of upland, conveying storm water only, and were identified as non-jurisdictional features.
