C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The perennial tributary appears to have been channelized characterized be a straight, non-meandering channel. The perennial

tributary is approximately 20 feet wide. Water is apparent within the perennial tributary channel throughout the year on Google Earth Pro time laps function. The channelized perennial tributary flows southeast into a more naturalized channel identified as Rantowles Creek that then flows south into the Stono River a TNW.

These wetlands are a part of and contiguous with a larger wetland system identified as Round Savanna Swamp on the USGS topographic map. This larger wetland system, to include the 0.72 acre of wetlands on site, can be seen on the USDA soils survey, LIDAR, and infrared aeriels. Round Savanna Swamp flows south into and is contiguous with Horse Savanna Swamp. Moving further south this wetland system flows into and surrounds the perennial tributary described in Section III.D.2 above. In other words, the wetland system shares boundaries with the perennial tributary.**
