C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This determination covers an 118.92 acre parcel located in the extreme southwestern corner of Horry County South Carolina. Site use is a mixture of forested areas and commercial golf course operations. The wetland boundaries / limits were established by the 1987 wetland delineation manual and Atlantic Coastal Plain regional supplement. Wetland 2, 3, 4, & 6 are situated within the manipulated grounds of a commercial golf course and at one time prior to mowing and maintaining may have exhibited a discernable channel. However, in the present condition an open and flowing channel is not visible from areal photography, but a continuation of the wetland is obvious. Currently, wetlands 2, 3, 4, & 6 continue offsite and is eventually bisected by the the OWHM of the offsite perennial RPW. This unnamed RPW discharges directly into the Waccamaw River, a named TNW.

However, pre Clean Water Act disturbance along the perennial RPW in the creation of two jurisdictional impoundments along a portion of this drainage system, once identified as a major drainage (M-45) in the Feasibility Study of Requirements for Main Drainage Canals in Horry County South Carolina, but in no way severed jurisdictional. Additionally, the tributary characteristics remain upstream and offsite further supporting the continual connection through wetland 7 and both jurisdictional impoundments onsite. Wetland 7 and the two jurisdictional impoundments continue offsite and is eventually bisected by the the OWHM of the offsite perennial RPW. This unammed RPW discharges directly into the Waccamaw River, a named TNW.
