C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review is comprised of 23.39 acres and contained no Waters of the U.S. (WOUS). This site is comprised of hydric (Leon, Echaw, Pocomoke, Witherbee, Yauhannah) soils. Wetland hydrology was present within the boundaries of Wetland 20, however it was found to be isolated due to its hydrologic separation from other Waters of the US. No surface or subsurface connection were evident during the site visit or could be found after a review of aerial photography, soil survey data, NWI data, or USGS Topographic Maps. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical, or biological connection, this wetland is isolated and not connected to any other Waters of the US. Horry county NWI data depict the site as containing wetlands. The isolated wetlands are approximately 200 linear feet from the nearest WOUS (preserved wetlands) feature as depicted on USGS topographic maps and Google earth true color aerial imagery.

Additionally, the site contains five upland excavated non-jurisdictional ditches and five upland excavated ponds that lack any features consistent with WOUS.
