itself is a manmade feature out of uplands for the sole purpose of drainage. The entire section within the project site is contained within a culvert below the access road. The edges of the road were checked for hydric indicators and none were found. Additionally, a 0.27 acre pond excavated out of surrounding uplands is on site. The pond does not feature discretely confined in/outflows and only receives recharge via direct storm water and associated sheet-flow. Neither of these features were deemed to be jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The pond does not feature discretely confined in/outflows and only receives recharge via direct storm water and associated sheet-flow. Neither of these features were deemed to be jurisdictional.

Data source comments: Dillon Quadrangle depicts an upland site with the only aquatic feature being a solid blue line running through a 10ft section of the access road, this feature correlates to the position of the drainage ditch mentioned in section(s) II.B.2., III.F., and IV.B. The Dillon County soil survey depicts three soils within the site, including Fuquay sand (0-6% slopes) (FuB), Lakeland sand (0-6% slopes) (LaB), and Johnston-Rutlege association, frequently flooded (JR). Of the on-site soils only Johnston-Rutlege association is listed on the 2016 South Carolina Hydric soils list. No soil samples found on-site by the Corps or the applicant's consultant were found to meet both hydric soils and hydrology criteria of wetlands. NWI maps depict the vast majority of the site as upland cropland/pasture (U21), with one small area of open water (PUBHx) correlating to the location of the excavated pond, and one area of palustrine forested wetlands (PFO1B) where the storm water ditch crosses the access road. LiDAR data supports a flat to convex project site that slopes into off-site wetlands / drainage basin. LiDAR shows one excavated pond within the eastern portion of the site and a manmade drainage ditch lacking sinuous flow cutting through the access road on the western portion of the site
