C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

According to an April 29, 2019, submission from the applicant's consultant, AECOM, this project area was verified to be within upland areas and the project itself is designed to avoid any WOTUS impacts, with the closest resources being a tributary that is ~5-10 linear feet from the termination of this project and wetlands adjacent to the eastern side of the project site. Per the April 29th submission: "One wetland (WET01-PSS) was identified adjacent to the project area. This wetland is classified as a scrub-shrub/forested palustrine wetland and will not be permanently impacted by the project's construction activities. The project was redesigned at this location to avoid impacting the wetland by installing curbing and abutting the sidewalk to the curbing allowing more room to add fill without impacting the wetland." ... "One waterbody was delineated and identified adjacent to the project area. This non-wetland waters feature was a tributary to Little Pee Dee River, which was located along the northern boundary of the delineated wetland (WET01-PSS). This waterbody feature flows in a northwesterly direction and transects MLK Jr. BLVD. There will be no impacts to this feature. The sidewalk will terminate approximately 18 LF from the water feature's banks." The exact distance from the tributary to the project site could not be verified by the Corps and appears to be less than 18 linear feet, however this feature is completely outside of the scope of the project area per the plans titled: "Project Area for MLK Jr. Sidewalk Project / SAC-2019-00750 / 0.12 acres", dated April 4, 2019.

Data source comments: The Dillon East Quadrangle USGS topographic map depicts the project site as forested and non-forested land abutting a road (MLK Jr.) to the east. The project site cuts through one solid blue line feature, an unnamed culverted tributary that receives flow from the Little Pee Dee River, however, the current location of this feature is known to be completely outside of the project area. Dillon County soil survey, sheet 12, depicts six soils types within the project area, including: Coxville fine sandy loam (Cx), Rains fine sandy loam (Ra), Pantego loam (Pa), Lynchburg sandy loam (Ln), Dunbar fine sandy loam (Dn), and Dothan loamy fine sand (DaA); Cx, Dn, Ra, Ly, and Ln are listed as hydric on the 2016 SC hydric soils list. National Wetland Inventory maps depict the majority of the site as a matrix of upland types, including: transportation / utilities (U14), cropland / pasture (U21), residential (U11), and commercial (U12). The eastern side of the site is depicted as palustrine scrub/shrub wetlands (PSS1A/F), this area is along a roadway right of way that is maintained as a non-paved roadway shoulder and ditch. LiDAR digital elevation model data illustrate that this site abuts a roadway and does not cut through any clear depressions indicative of aquatic resources. Aerial imagery depicts the site as a non-forested road right-of-way / shoulder.
