**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area is a 4.31 acre parcel identified as Horry County TMS# 161-00-03-124 & 005. The project area is surrounded by development consisting of single-family residential, and commercial. The site contains potential wetland areas, but these areas lack all three parameters which define a wetland (see section 2.B.II of this document.). Review of the submitted site photos reveal an area that has been under brushed. Soil Samples site photos depict within the upper 12 inches greater than 30 percent uncoated sand grains, and no hydrology or indicators of hydrology. In addition, the project area contains an upland excavated ditch that drains only uplands. The onsite ditch is not considered a tributary since excavated within uplands and draining only uplands.
