- **B.** Typical year assessment(s): Antecedent Precipitation Tool (APT) results for typical year determination were calculated for the date the site was visited by the consultant (7/27/2020) and the date the site was visited by the Corps (12/18/2020). On July 27, 2020, the conditions were normal; however, on December 18, 2020, the conditions were wetter than normal.
- C. Additional comments to support AJD: The determination covers 101.54 acres with 8 jurisdictional features and 1 excluded (non-jurisdictional) feature. The project area includes 6 (a)(2) waters, 2 (a)(4) waters, and 1 excluded (b)(1) water. Jurisdictional Tributaries 1, 3, 4, and 7 are perennial (a)(2) waters and Jurisdictional Tributary 2 and 5 are intermittent (a)(2) waters. Jurisdictional Wetland 6 directly abuts Jurisdictional Tributary 7 making it an (a)(4) water. Jurisdictional Wetland 8 directly abuts Jurisdictional Tributary 4 making it an (a)(4) water. Excluded Water Wetland is completely encompassed by uplands and lacks a direct or indirect surface water connection to (a)(1)-(3) waters. Since the wetland does not abut an (a)(1)-(3) water and is not inundated by an (a)(1)-(3) water, the Corps has determined the wetland to be excluded under the Navigable Waters Protection Rule.
