- C. **Typical year assessment(s):** Antecedent Precipitation Tool (APT) data for typical year determination was calculated based on field collection date denoted on the wetland determination data forms (February 2, 2021). Output from the APT indicated "normal conditions" at the time of data collection by the agent with a condition value of 13. ATP outputs with a condition value greater than 14 indicate "wetter than normal" conditions onsite and may not accurately represent typical year hydrologic conditions. For this assessment, a total of 7 weather stations within a ~18-mile radius was used.
- **D.** Additional comments to support AJD: This 12-acre forested site contains 3.89 acres of jurisdictional wetlands and 0.83 acres of excluded waters (non-adjacent wetlands).
