- B. Typical year assessment(s): Antecedent Precipitation Tool (APT) data for typical year determination was calculated based on field collection date denoted on the wetland determination data forms (January 12, 2021). Output from the APT indicated "normal conditions" at the time of data collection by the agent (Ecological Associates) with a condition value of 13. ATP outputs with a condition value greater than 14 indicate "wetter than normal" conditions onsite and may not accurately represent typical year hydrologic conditions. For this assessment, a total of 6 weather stations within a ~14-mile radius was used.
- **C.** Additional comments to support AJD: This 0.90-acre site can be described as a cleared, partially developed urban lot. The site contains no jurisdictional waters.
