- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: Terrain features, LiDar Data, Soil Maps and onsite conditions (observed May 24, 2021) all indicate that the 1 acre homesite (noted in red on the Gochnauer Residence Aquatic Resources and Homesite Map) does not contain any aquatic resources, including aquatic resources that would be subject to regulatory jurisdiction under Section 404 of the CWA or Sections 9 & 10 of the RHA.
