- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.  
Explain: **Fourteen potentially jurisdictional wetlands, totaling 5.23 acres, are located within the project area. These depressional wetlands are depicted as forested on the aerials and as uplands on the topographic map. The soil survey maps these areas as Eulonia loamy fine sand, Bladen fine sandy loam, and Yauhannah fine sandy loam. The NWIs map the wetlands as PSS1/4C, PFO4/1Bd, and PSS1C. All but one of these wetlands are depressional wetlands with no**

discernible outfall. Non-jurisdictional Wetland #2 has a non-jurisdictional ditch exiting it and continuing east; however, this non-jurisdictional ditch contains an upland break immediately outside of Non-jurisdictional Wetland #2 and does not contain indicators of flow. Based on information submitted by the agent, all of the onsite non-jurisdictional wetlands were determined to be surrounded by non-hydric soils and have no connection to any other potential WOUS. Therefore, Non-jurisdictional Wetlands 1-14 were determined to be isolated and non-jurisdictional.

These depressional wetlands exhibited hydric soils and indicators of hydrology, which satisfies the criteria set forth in the 1987 Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement. These wetlands have hydrophytic vegetation present. All water located within or draining toward these wetlands has no connection to any WOUS. Additionally, these wetlands are completely surrounded by uplands, which further disrupts any possible connection to any WOUS. Because of the lack of discernible outfall, topography grades and lack of evidence of chemical, physical, or biological connection, these fourteen wetlands were determined to be isolated, non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Fourteen potentially jurisdictional wetlands, totaling 5.23 acres, are located within the project area. These depressional wetlands are depicted as forested on the aerials and as uplands on the topographic map. The soil survey



maps these areas as Eulonia loamy fine sand, Bladen fine sandy loam, and Yauhannah fine sandy loam. The NWIs map the wetlands as PSS1/4C, PFO4/1Bd, and PSS1C. All but one of these wetlands are depressional wetlands with no discernible outfall. Non-jurisdictional Wetland #2 has a non-jurisdictional ditch exiting it and continuing east; however, this non-jurisdictional ditch contains an upland break immediately outside of Non-jurisdictional Wetland #2 and does not contain indicators of flow. Based on information submitted by the agent, all of the onsite non-jurisdictional wetlands were determined to be surrounded by non-hydric soils and have no connection to any other potential WOUS. These wetlands were previously determined to be isolated in a letter dated November 1, 2007. Therefore, Non-jurisdictional Wetlands 1-14 were determined to be isolated and non-jurisdictional.

Three non-jurisdictional ditches are also present on site. These three ditches have no indicators of flow and were determined to be man-made. Therefore, the three onsite ditches were determined to be non-jurisdictional.

Jurisdictional features located on site are documented on JD Form 2 of 2 of this determination.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Jurisdictional Wetland 1 (JW1) was determined to directly abut the on site perennial RPW. The aerials and topographic map depict this wetland as a portion of the wetland system which surrounds Todd Swamp, the on site perennial RPW. The soil survey maps this wetland system as Meggett and Ogeechee, which are hydric soils. The NWIs map this wetland as palustrine forested, which abuts the riverine system located along the southern property boundary. The onsite tributary located along the southern property boundary was determined to flow year round based on a review of the aerials, topographic map, soil survey, NWIs, and information submitted by the agent. The aerials and topographic map depict this feature as a man-altered tributary that flows east toward the Waccamaw River. The NWIs map this tributary as a riverine system (R2UBH), and the soil survey maps this tributary as Ogeechee and Meggett, which are hydric soils. This tributary is named Todd Swamp on the aerials and topo map and was determined to have perennial flow.
