The onsite linear conveyance does not appear in aerial photographs and does not appear as a blue line feature in topo maps. evidence relatively permanent flow. For these reasons, the linear conveyance was determined to be non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act.

Summarize rationale supporting conclusion that wetland is “adjacent”: The project review area includes one wetland, Wetland 1. Wetland 1 flows through an onsite, non-jurisdictional linear conveyance that connects to an offsite, roadside linear conveyance that flows along Old Fort Road where it discharges directly into Ellory Swamp south of N. Mulberry Drive. Ellory Swamp is a large, freshwater wetland system that is contiguous with the West Branch of the Cooper River, which is the TNW. The onsite wetland is adjacent to the West Branch of the Cooper River by a surface hydrologic connection from the onsite wetland through the on and offsite linear conveyances, through Ellory Swamp, and to the West Branch of the Cooper River. It should also be noted that the large wetland system is also contiguous with Molly Branch, which is also a Section 10 water and therefore a TNW. Based on this information, the onsite Wetland 1 is jurisdictional and subject to regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
