C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A potentially jurisdictional water is located along the southeastern property boundary. This feature is depicted on the topographic map and aerials as a straight linear feature that connects to an off-site straight linear feature that continues southeast into a tributary of the Kiawah River. The NWIs map the on-site linear feature as R5UBFx, and the soil

survey maps this feature as Dawhoo & Rutledge, a hydric soil. The previous determination on this site found this site consisted entirely of uplands (SAC-2007-00470; letter dated February 26, 2015). Therefore, this feature was determined to be a non-jurisdictional ditch. The remainder of the 34.224-acre site, which is depicted as uplands on the topographic map and mapped uplands on the NWIs, was determined to consist of uplands.
