Explain: **This site contains 2.887-acres of freshwater wetland that is determined to be non-jurisdictional as federally defined by the 1987 Corps of Engineers Wetland Delineation Manual. The wetland on site is part of a larger wetland system that extends past the site boundaries. The larger wetland system appears to have no apparent physical, chemical, or biological connection to waters of the U.S., and has no apparent surface or shallow subsurface hydrologic connections to waters of the U.S. The wetland system also has no interstate or foreign commerce. For these reasons, the**

wetland on site was determined to be isolated and therefore is non-jurisdictional and not subject to Section 404 of the CWA or Section 10 of the RHA. A previous AJD dated February 26, 2019 under SAC-2008-02065 located north of this site determined a wetland that the on-site wetland is a part of is isolated and non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site contains one non-jurisdictional isolated wetland. The wetland is connected to a larger wetland system that goes off site. The larger wetland system is surrounded by uplands and does not have connection to waters of the U.S. or interstate and intrastate commerce. For these reasons, the wetland located on site was determined to be non-jurisdictional and not subject to Section 404 of the CWA or Section 10 of the RHA. The JD under SAC-2008-02065 also determined the on-site wetland appears to be isolated and non-jurisdictional.
