C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form discusses a 1357 acre site that includes a mixture of forested uplands, wetland, and tributaries. Currently the site is undeveloped and is slated to be utilized as a solar farm. The site contains 26 isolated wetlands that total 21.65 acres in all. These isolated wetlands are situated in upland areas and do not connect chemically, biologically, or physically to other WOUS in the area.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This basis form discusses a 1357 acre property located in the Sampit River watershed in Georgetown County SC. Each of the jurisdictional wetlands onsite abut the OWHM of Summons Swamp. Summons Swamp is a tributary onsite that continues offsite to the north under Saints Delight Road and forms a portion of the headwaters for the Sampit River, a named tidal TNW.

It was determined that the tributary flows at least 90% of the year under normal climatic conditions. The stream geomorphic indicators of perennial flow was a channel within the bed and banks visible from aerial imagery. In addition, other hydrologic indicators depicted on USGS topographic maps, such as a named solid blue line, indicate perennial flow. Aerial photos depict a signature of a defined channel discharging into the Sampit River. Topographic maps depict a symbol (solid blue line) which represents a tributary with perennial flow, Georgetown County Soil Survey depicts a symbol that represents a tributary with perennial flow.

The Other Jurisdictional WOUS 1 feature is a impoundment (pond) which was partially excavated out of wetlands that continue offsite and abut the OWHM of Summons Swamp, a perennial RPW.

Jurisdictional wetland 3 continues offsite to the southwest and eventually turns east to abut Summons Swamp. Google aerial maps confirmed. See administrative record for copy of aerial photo of wetland continuation.

Jurisdictional wetlands 1,2,5,7,9,10 are located primarily within the property boundary and abut the OWHM of Summons Swamp.
