relatively permanent flow. No evidence of OHWM was observed. The features appeared to be road-side drainage features along the fields.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This JD form documents the jurisdictional status of one perennial RPW and wetlands adjacent a perennial RPW located offsite. The adjacency is directly abutting the tributary known as Cook Branch. On this basis, the perennial RPW and the adjacent wetlands documented on this form are within the jurisdiction of the Clean Water Act. These features were determined to have a direct hydrologic connection to the downstream TNW via the offsite perennial RPW, Cook Branch. Because the RPW was not located onsite, it was observed in the field from a road crossing at Cameron Highway. Aerial photography, NWI and topographic maps confirm that the feature provides a direct downstream connection to Four Hole Swamp. Four Hole Swamp then flows directly into the Edisto River, a TNW.
