Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Two non-jurisdictional ditches surround the subject property. Ditch A is a non jurisdictional roadside ditch located on the north end of the property. This linear feature is approximately 3' wide and 4' deep with no defined bed and bank features or ordinary high water mark. This feature appears dug in uplands and drains uplands and was not flowing at the time of survey. Therefore, this linear feature is non jurisdictional and not subject to Corps regulatory authority under the Clean Water Act. Ditch B runs along the south boundary and along the Eastside of the property. This conveyance were heavily channelized with vegetation growing in most of the channel. This conveyance was flowing at the time of survey. This was most likely due to the amount of rainfall in the area prior to survey, The channel was 3.5' wide and 5' deep with a wetted width/depth of 1'x < 6 in. This linear feature did not exhibit tributary features such as an ordinary high water mark or consistent flow regime and appears to be dug in uplands, draining uplands. Therefore, this linear feature is non jurisdictional and not subject to Corps regulatory authority under the Clean Water Act.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
