- B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 0.73 acre tract that was determined to contain 0.04 acres and/or 173.55 linear feet of jurisdictional waters of the United States, including salt marsh, tidal wetlands and/or open water tidal areas which are considered navigable waters of the United States pursuant to 33 CFR 328.3(a). There are no federally defined freshwater areas which are subject to the jurisdiction of this office on the site in question. Some or all of these areas are considered "Critical Area" by the South Carolina Department of Health and Environmental Control, Office of Ocean and Coastal Resource Management (OCRM). A review of aerial photographs reveals a partially developed site that abuts an estuarine system to the east. This depiction is reaffirmed by NWIs, USGS topo maps, and Horry County soil survey information. Additionally, approved JD 2005-35915 issued on December 20, 2005, and all supporting documentation therein, supports the current delineation.
