C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area addressed in this form contains approximately 3.35 acres of uplands located off of farrow parkway east of U.S Highway 17 Bypass in Myrtle Beach, Horry County, South Carolina. Aerial photographs show the project area as being forested and partially cleared. The USGS topographic survey information located within the Myrtle Beach Quad depicts forested uplands and is void of any blue line features or other symbols that typically represent a wetland area or waters of the U.S. The NWI map depicts the project area as being comprised of forested wetland (PF04/1Bd) that are considered to be ditched/drained, transportation/utilities (U14), while the majority of the project area is upland planted pine (U42P). Soil survey information depicts the project area as being comprised of the hydric soils Ogeechee and Yemassee. Ogeechee contains 100% hydric inclusions while Yemassee contains 2% hydric inclusions. Data forms submitted by the agent indicate that hydrological indicators were not observed in either data point locations and the area was in normal rainfall for the year. Due to the consistency in the depiction of uplands throughout the USGS topographic information, NWI maps, aerial photographs, data forms, and previous determination (SAC 2011-01124-3) the project was determined to consist entirely of uplands. .
