C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: The onsite site aquatic resource was determined to contain open water and portions of inundated vegetation are as that meet the three parameters that define a wetland outlined in the 1987 Wetland delineation manual. For this reason, the both wetland acres and impoundment acres are being combined for a total of 0.79 acres. The onsite aquatic resource outfalls directly to House Creek which is considered a TNW; therefore, both the wetland portion and impoundment portion are adjacent, non-abutting the downstream TNW.

The parcel is partly developed with a community building and in addition contains a 0.79 acres wetland/impoundment. The aquatic resource located within the project area contains an open water body portion with no vegetation but in addition contains inundated vegetated areas considered as wetlands; therefore, wetlands acres and the impoundment area have been combined for a total 0.79 acres. The aquatic resource was determined to drain to the TNW (House Creek) via a stormwater system that consists of open ditches, culverted drains and open waterbodies. The TNW is located to the southeast downstream. Based on review of the applicant's submittal and review of available desktop resources documented in Section IV above, a site visit was not warranted.
