C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A large portion of the tract is developed and consist of a medical facility with associated parking areas and roadways. One man-made upland excavated storm water pond is located onsite and was determined to be non-jurisdictional. A site visit conducted on 10/18/17 revealed non-hydric soils adjacent to the pond. The topographic survey information within Brookgreen Quad depicts the site as forested uplands that do not contain any blue line features or any other symbols that would typically represent a WOUS. NWIs depict the majority of the project area as uplands. The non-jurisdictional storm water pond is depicted as excavated permanently flooded palustrine unconsolidated bottom. .
