C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The subject property in their review encompasses approximately 26 acres of agricultural field and roadside fallow areas, south of the city limits of Darlington, South Carolina. The site is mapped uplands (U21) on NWI resources as cited above and the Darlington County Soil Survey depicts the site as completely comprised of Rains sandy loam which is listed as hydric for 95% of its mapped component.

Additionally, a previous jurisdictional determination (JD) issued on December 20, 2016, determined the area to be uplands, lacking the appropriate hydrology or hydrophytic vegetation. The previous JD indicated that the site was comprised of 100% uplands which was also confirmed in the field by USACE staff. A comparison of recent aerial imagery indicates that site conditions are equivalent to those observed in 2016 and no indication of a change in hydrology or hydrophytic vegetation was evident. The area, which is slightly larger than the 2016 review, is determined to be comprised entirely of uplands.
