**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 95.41 acre corridor that consisted of forested uplands, existing roadways and parking lots and contains 2,375 linear of a jurisdictional perennial tributary. Several tracts located within the corridor were determined to consist of uplands containing only the perennial tributary (i.e. no wetlands). Tracts that were not previously observed under separate JDs or that did not consist of an existing roadway or parking lot, were observed in the field. Potential wetlands on-site were examined during the site visit conducted on 10/23/18 and determined to lack indicators of hydric soils (i.e. greater than 30% uncoated sand grains) and/or hydrology and therefore do not meet the required criteria set forth in the 1987 delineation manual and the Coastal Plain Regional Supplement for identification of a wetland..**
