C. SIGNIFICANT NEXUS DETERMINATION

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. The site in questions contains 5.42 acres of jurisdictional freshwater wetlands that directly abut Socastee Swamp a pRPW. A site visit conducted on October 23, 2018 revealed obvious topographic breaks between onsite wetlands and uplands. Flow was observed within the pRPW onsite and a continuous ordinary high-water mark was observed.

One isolated non-jurisdictional wetland, two non-jurisdictional upland excavated ponds and one upland excavated ditch are located on site. These features are addressed on basis form 1 of 2 of this determination.
