Explain: **There was one feature that was reviewed on-site on the eastern boundary which consists of a small (0.30 acre) upland dug pond. The pond appears to be constructed for part of a previous agricultural operation. Based on review**

of the USGS Topography, NWI, historic aerial imagery, soil data (Alaga loamy sand – not hydric soil), and a site visit on July 31, 2018 the feature appears to have been excavated entirely in uplands. The NWI lists the feature as PUBHx but does not have anything connecting to it. The historic Lexington County soil map (page 46 & 52) does not show any aquatic features in or around where the pond is located. During the field inspection, it was clear that the pond water level experiences great fluctuation and receives water from overland flow. While there was an observed outflow, the device sits very high above the water level and was likely used in emergency situations as to not flood the adjacent road. Looking at where the water runs off-site, it does not appear that this historically or currently serves as a connection to waters of the U.S. It appears that the water would end up in a roadside ditch that runs off-site. Additionally, the excavated material to construct the pond seems that it was used either for the road or to contain the roadside ditch. It was therefore determined that the feature is upland dug and not jurisdictional under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
