jurisdictional. Wetland 1 (0.24 acre), Wetland 2 (1.05 acres), Wetland 3 (0.18 acre) and Wetland 4 (0.48 acre) are surrounded by uplands, they have no ditches or swales coming out of them that would provide a surface hydrologic connection to other wetlands or Waters of the U.S., and there is no visible evidence that discrete hydrologic flow through uplands to other wetlands or Waters of the U.S occurs. In addition to not having a surface hydrologic connection, the wetlands have no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to Waters of the U.S. The wetlands also have no apparent ecological interconnection to Waters of the U.S. For these reasons, these wetlands were determined to be isolated and non-jurisdictional; therefore, they are not regulated by Section 404 of the CWA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

purpose of borrow material/mining. The ponds consist of open water and do not meet the three parameters of a wetland. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S. In addition a linear feature is also present within the project review area. The linear feature is a ditch that is located adjacent to the internal road and was excavated from uplands. The ditch provides a drainage outlet for the non-jurisdictional upland excavated ponds.
