receiving upland stormwater from ditches located on the site, detailed later in this section. The stormwater control pond was excavated from uplands and initially served as a borrow pit for the adjacent residential development. Three (3) non-jurisdictional ditches were identified along the north, south and western boundary of the site. These features did not exhibit hydrologic indicators such as: ordinary high water mark, bed, bank, substrate and sediment sorting. Flow was not observed during the October 22, 2018 site visit. The ditches located on the northern and southern boundary of the site terminated in the stormwater control pond located on the western portion of the site.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is associated with a Charleston District Approved Jurisdictional Determination (AJD) (SAC 2011-0872-1Q / issued April 10, 2012). This AJD's review area was 6.54 acres which includes the 3.768 acres of the current JD request. The AJD determined a 1.2 acre borrow pit at the west end of the tract and a conveyance that crossed north-to-south at the tract's west boundary were non-jurisdictional features. The AJD indicates the borrow pit was intended for upland stormwater runoff and was excavated from uplands, and that the conveyance originates in upland agricultural fields north and west of the site, and does not show hydrological indicators such as sorting, scouring, or a clear Ordinary High Water Mark. Additionally, no flow was observed in the conveyance during two (2) site inspections, fall 2011 and spring 2012.
