Explain: **Within the project site are eight (8) ponds excavated out of uplands for the creation of golf course water hazards. These ponds were constructed and maintained for the development of the golf course which consists of the remainder of the project area. Furthermore, these features were assessed and deemed non-jurisdictional in a March 13, 2015, approved jurisdictional determination. These features are approximately illustrated, with slight size and location variances, on the submitted plat, titled “Map of 108.26 Acres of Land / Socastee Township, Horry County, South Carolina / Wetland Exhibit”, dated February 26, 2015. Since construction, these features have only been used for the purpose of upland water containment and aesthetics; all available remote data sources (aerials, site photographs, etc.) show these features have not been altered to impound WOUS.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This site is described as a 108.26 acre developed golf course with 8 excavated ponds. This site was deemed to be uplands in its entirety in approved jurisdictional determination (SAC-2015-00126-3JY), dated March 13, 2015; the approved jurisdictional determination covered in this form accounts for the exact same project site footprint and possible aquatic resources within the project site.

Within the project site are eight (8) ponds excavated out of uplands for the creation of golf course water hazards. These ponds were constructed and maintained for the development of golf course, which consists of the remainder of the project area. Furthermore, these features were assessed and deemed non-jurisdictional in a March 13, 2015, approved jurisdictional determination. These features are approximately illustrated, with slight size and location variances, on the submitted plat, titled “Map of 108.26 Acres of Land / Socastee Township, Horry County, South Carolina / Wetland Exhibit”, dated February 26, 2015. Since construction these features have only been used for the purpose of upland water containment and aesthetics; all available remote data sources (aerials, site photographs, etc.) show these features have not been altered to impound WOUS.

The Myrtle Beach Quadrangle topographic map depicts a forested and non-forested tract with one area of wetland symbology in the northern section of the site; this area has been developed into a portion of the golf course and features two excavated ponds. USDA / NRCS Horry County soil survey, sheet 90, depicts four soil types within the project site, including: Meggett loam, Ogeechee loamy fine sand, Yauhannah fine sandy loam, and Yemassee loamy fine sand. All soil types within project site are listed as hydric on the 2017 NRCS hydric soils list for Horry County, South Carolina. National wetland inventory maps depict an upland site with areas of ponds (PUBHx), lakes (LIUBHx), and palustrine scrub-shrub wetlands (PSS4/1Bd) in the same general area as the eight excavated ponds; the remainder of the site consists of upland planted pine (U42P).
