these ponds were determined to have been excavated out of uplands and are therefore determined to be non-jurisdictional. The site also includes a 0.78 acre isolated non-jurisdictional wetland. The wetland is surrounded on all sides by uplands that disrupt any hydrologic connection between the wetland and any other WOUS. The entire perimeter of the wetland was observed in the field during a site visit conducted on 10/18/2019 . .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

NWIs depict a tributary/drainage feature onsite in the upper western corner; however, a site visit conducted on 10/18/19 revealed that this feature does not exist on site. There is a golf course pond located in close proximity to the location where the linear feature is depicted. NWIs depict the pond and linear feature as separated by uplands. Based on current NWIs and the site visit conducted on 10/18/19 the upland excavated pond does not appear to be associated with or excavated from the depicted blue line feature. ..
