- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Three potentially jurisdictional wetlands located within the project area was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although the wetlands meet the criteria set forth in the 1987 Wetland Delieation Manual and the 2010 Coastal Plain Supplement, a site visit conducted on 9/27/19 revealed that the wetlands onsite are completely encompassed by soils that do not meet the hydrology criteria, and therefor disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface or subsurface hydrologic connection is inhibited.**

C. SIGNIFICANT NEXUS DETERMINATION

C. SIGNIFICANT NEXUS DETERMINATION
