- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Three ditches were observed in the field and determined to be non-jurisdictional. Two of the ditches were man-made and excavated in uplands and did not exhibit characteristics of at least seasonal flow throughout the year. The third ditch is potentially a man-altered feature located within a low-lying area that exhibited sinuosity and had flowing water during the site visit. However, the bed of the ditch was full of debris that backed up water along the ditch and was slowly releasing recent rain water through the ditch. A clear and defined OHWM was also NOT observed within this ditch. This ditch also did not exhibit characteristics of at least seasonal flow throughout the year.

In addition, the southwest portion of the tract was lower in gradient and exhibited characteristics of a potential wetland. This area was previously determined to be wetlands in a PJD (SAC-2012-00362, Letter dated April 2, 2015). However, after further field observations on October 29, 2019 and information submitted by the consultant, this area was determined to consist entirely of uplands. Four (4) soil samples were taken within this area during the site visit on October 29, 2019. All but one sample exhibited greater than 30% uncoated sand grains within the upper 6" of the soil profile under moist conditions, indicating a non-hydric soil. Saturation was observed at greater than 24" at the lowest contour grade of the tract. In addition, no other indicators of hydrology were observed.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site visit was conducted on October 29, 2019. There is a current Preliminary Jurisdictional Determination (PJD) (SAC-2012-00362) which was issued on April 2, 2015, for the entire Goretown Mine site that includes the 29.3 acre tract referenced in this request. The PJD identified waters of the US on the 29.3 acres assessed on this form. However, after further field observations, the Corps has determined that the 29.3 acre portion subject to this review consists entirely of uplands. The southwest portion of the tract is lower in gradient and exhibited characteristics of a potential wetland. However, after further field observations on October 29, 2019, this area was determined to consist entirely of uplands. Four (4) soil samples were taken within this area during the site visit on October 29, 2019. All but one sample exhibited greater than 30% uncoated sand grains within the upper 6" of the soil profile under moist conditions, indicating a non-hydric soil. The soil observed in the potential wetland area resembled a Rutlege (hydric) soil with a value of 2 and chroma of 1 (10YR 2/1) in the upper 8-10 inches. However, the upper 6 inches of the soil profile exhibited greater than 30% uncoated sand grains under moist conditions. According to the S7 (Dark Surface) soil indicator in the 2010 Regional Supplement to the Corps of Engineers Wetland Delineation Manual: Atlantic Gulf Coast Plain Region (Version 2.0) "Where the percent coverage by organic matter is less than 70 percent, a Dark Surface indicator is not present." Saturation was observed at greater than 24" from the soil surface at the lowest contour grade of the tract. In addition, no other indicators of hydrology were observed.

Three ditches were observed in the field and determined to be non-jurisdictional. Two of the ditches were man-made and excavated in uplands and did not exhibit characteristics of at least seasonal flow throughout the year. The third ditch is potentially a man-altered feature located within a low-lying area that exhibited sinuosity and had flowing water during the site visit. However, the bed of the ditch was full of debris that backed up water along the ditch and was slowly releasing recent rain water through the ditch. A clear and defined OHWM was also NOT observed within this ditch. This ditch also did not exhibit characteristics of at least seasonal flow throughout the year.
