Waters A and B are artificial (manmade non-wetland) features that were constructed in the uplands in 2005 or 2006. These features do not have connections to any other aquatic feature. Such features are generally not considered waters of the U.S. [51 FR 41217 (November 13, 1986)]. Water C is a forested wetland feature located in the eastern part of the review area. This wetland is documented in Section III Part F of this form and has no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection. There is no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. On this basis, this office has determined that this wetland is isolated from waters of the U.S. and is not within the jurisdiction of the Clean Water Act. Based on this information, Waters A, B, and C are not waters of the U.S.

Parts of the review area have standing water visible in aerial imagery in various years and appear to be potential wetlands. However, data points taken by the consultant in these areas indicate that all three wetland parameters described in the 1987 Corps of Engineers Wetland Delineation Manual are not present. The consultant stated that the parcel is a horse pasture and is grazed. It is likely that water collects in these areas due to soil compaction and the lack of ground cover. Because these areas do not have all three wetland parameters, they are not considered wetlands and were not considered further.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Waters A and B are artificial (manmade non-wetland) features that were constructed in the uplands in 2005 or 2006. These features do not have connections to any other aquatic feature. Such features are generally not considered waters of the U.S. [51 FR 41217 (November 13, 1986)].

Water C is a forested wetland feature located in the eastern part of the review area. This wetland is documented in Section III Part F of this form and has no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection. There is no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. On this basis, this office has determined that this wetland is isolated from waters of the U.S. and is not within the jurisdiction of the Clean Water Act. Based on this information, Waters A, B, and C are not waters of the U.S..
