Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain:

The identified borrow pit was reviewed as a potentially jurisdictional water. The pit was created approximately 30 years ago, according to the landowner, for the purposes of obtaining material for a road. The borrow pit was excavated in uplands. The southwest corner does provide an outlet should the water levels rise due to significant rainfall where water would flow to the marsh. However, the area between the marsh and the pit is not defined with an

OHW, HTL, MHW, contained leaf litter and debris, included hummocks and microtopography preventing normal surface water flow from the marsh to the borrow pit and did not meet the 1987 Wetland Delineation manual criteria of a wetland. No hydrophytic vegetation was noted in or around the borrow pit or in the outlet area. Additionally, the landowner noted, high tide does not back up into the pit. An additional site visit was conducted around 5:30pm on November 16, 2021 during high tide which confirmed the lack of tidal connection.

33 CFR 328.3 provides definitions of both jurisdictional waters and non-jurisdictional waters. 328.3 (b)(9) defines non-jurisdictional waters and states “Water-filled depressions constructed or excavated in upland or in non-jurisdictional waters incidental to mining or construction activity, and pits excavated in upland or in non-jurisdictional waters for the purpose of obtaining fill, sand, or gravel;”.

Page 37105 of the Federal Register issued Monday 29, 2015, 328.3 (b) states that “(b) The following are not” waters of the United States” even when they otherwise meet the terms of paragraphs (a)(4) through (8) of this section.” Furthermore, (b)(4)(v) includes “Water-filled depressions created in dry land incidental to mining or construction activity, including pits excavated for obtaining fill, sand, or gravel that fill with water;”

Therefore, it is concluded that the approximate 0.08 acre borrow pit is not a jurisdictional feature.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
