**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

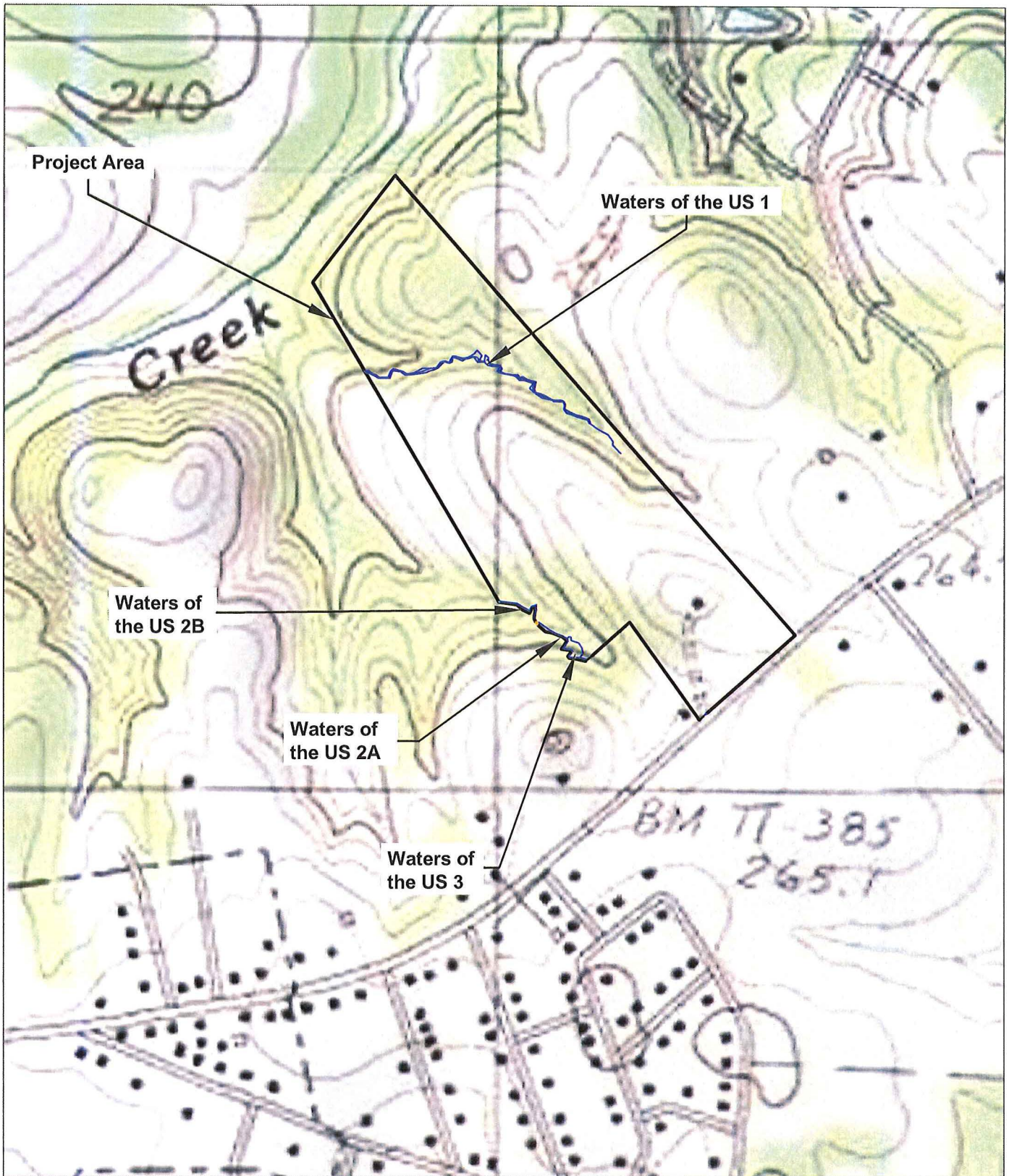

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form documents two jurisdictional tributaries and one jurisdictional wetland. RPWs 1, 2A, and 2B (2A and 2B are the same tributary, which leaves the site and returns before exiting to join Horsepen Creek) are described by the consultant as perennially flowing. Photos provided by the consultant show flow, clearly defined ordinary high water marks, and defined bed and banks. These tributaries are not shown on the topographical maps as blue lines, but as topographical signatures of the contour lines that indicate a topography that would be expected to be conducive to the formation of a channel. They are represented on the soils map as dashed lines. Based upon these factors, these two tributaries have been determined to flow perennially. Wetland 3 directly abuts and drains into pRPW 2A. The features are not separated by any kind of berm or barrier. This wetland is described by the consultant as a springhead that feeds pRPW 2A. Therefore, this wetland has been determined to directly abut pRPW 2A, described above as a perennial tributary. Per guidance from RGL 07-01, perennially flowing tributaries and their abutting wetlands are jurisdictional. Therefore all waters documented on this form are jurisdictional.
