**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

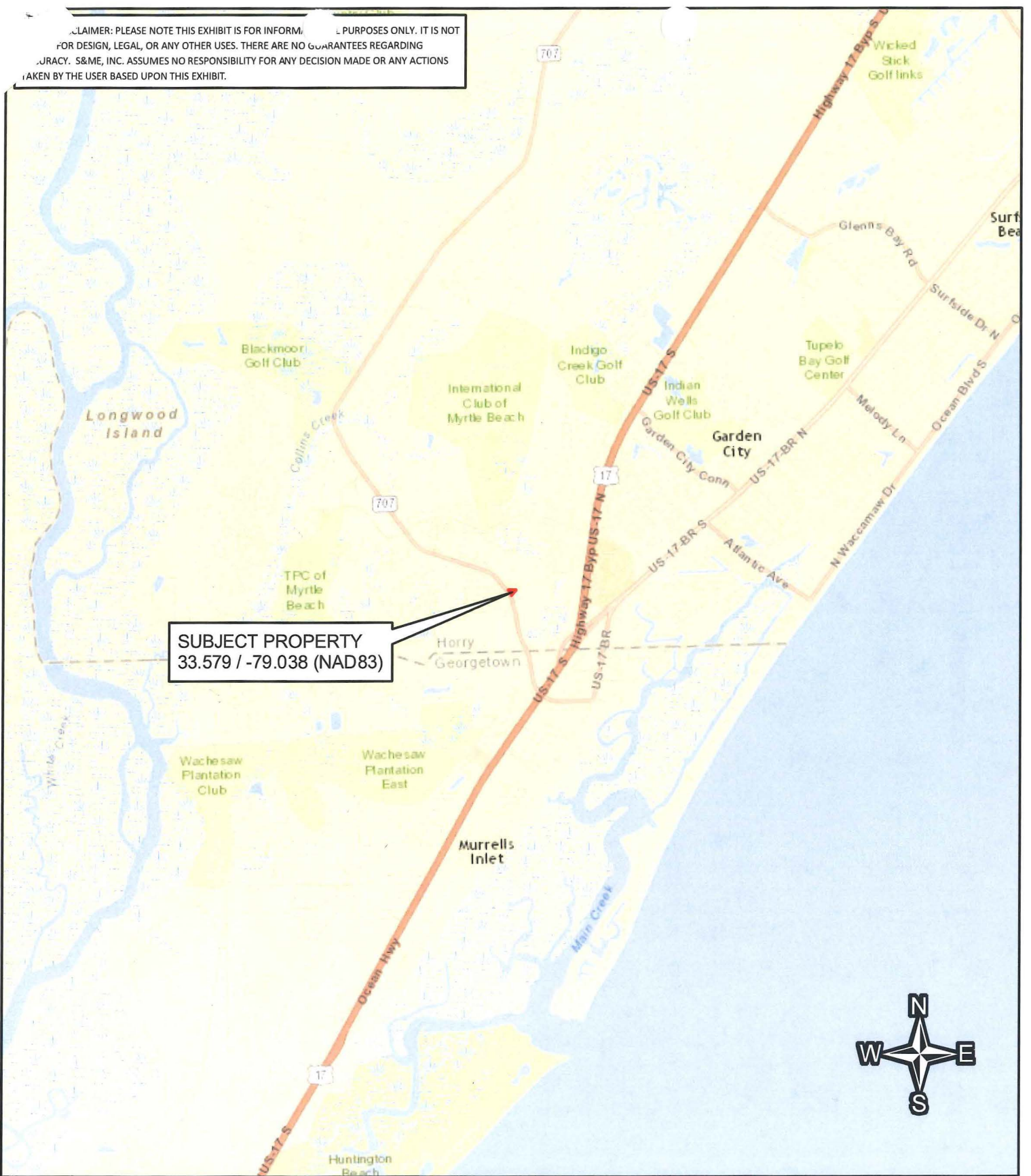

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is comprised entirely of uplands. The property is mapped as a Centenary soil type which is non-hydric and mapped as uplands (U42P) on NWI maps. In addition, there are no aquatic resources**

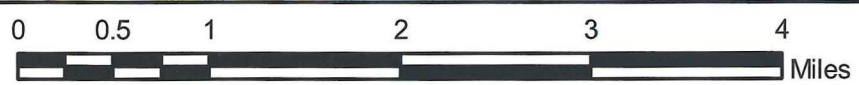
(i.e. wet areas, blue lines, etc.) depicted on topographic maps. Pictures in the file depict a non-hydric soil with well over 30% uncoated sand grains suggesting that the area is not inundated with water at least 2 weeks out of the growing season. Therefore, a site visit was not conducted and this site was determined to be uplands.
