C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The wetland boundaries were established by the 1987 wetland Delineation Manual. Wetland 1 and Wetland 2 (8.55 acres total) continue offsite and directly abuts the MHW of the Great Pee Dee River. The Great Pee Dee River is a tidally influenced waterbody at this location. Both Wetlands 1 and 2 in the project area meet all three parameters and displayed both saturation and inundation at the time of the site visit.

Within the project area is a small upland excavated pond excavated from uplands and therefore not an impoundment of any waters of the US. In addition, the project area contains three upland excavated non-jurisdictional ditches that have been determined to drain only uplands.
