

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area addressed in this form contains approximately 3.99 acres off of Todd Blvd west of SC Highway 544, in Conway, SC. Aerial photographs show the project area near densely populated residential and commercial areas. The USGS topographic survey information located in the Conway quad depicts the area as forested upland and shows no blue features or other symbols that would typically represent a water of the United States located within the project boundary. Potential wetlands on-site were examined during a site visit conducted by the agent on 8/09/2016 and determined to lack indicators of hydrology during a period of average rainfall and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland. The data forms showed soil with low chroma numbers however there was greater than 30% uncoated sand grains observed. Due to consistency in the depiction of uplands throughout the USGS topographic information, aerial photographs, and data forms, the project area was determined to be void of any aquatic resources.
