C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area addressed in this form consists of a 3.4 acre site located at 12270 Frontage Road, Murrells Inlet, SC 29576. Aerial photographs show an upland excavated non-jurisdictional pond located on the western portion of the project area. Aerial photos also show the site has been cleared, graded, and partially commercially developed. The NWI depicts this project area as containing forested wetland (FF01/4B) and upland planted pine (U42P). Based on previous determinations (SAC 84-99-1093 and SAC 84-2006-0384-3), review of aerial photographs, NWI maps, and data forms submitted by the agent it has been determined that the project area does not contain any wetland areas or other waters of the United States.
