Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project review area is 0.6 acre in size and consists of a linear conveyance only (top of bank to top of bank). The linear conveyance was excavated from uplands, drains only uplands, and is approximately 10 feet wide and 6 feet deep. It had water present at the time of the initial site visit in October of 2015, but that was following a 24-inch rain storm event. In addition, it appeared that water from the nearby mining operations, located outside of the project area but on the same property, had been pumped into the conveyance. For these reasons, the linear conveyance was determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project review area is 0.6 acre in size and consists of a non-jurisdictional linear conveyance only (top of bank boundaries of the linear conveyance) that is not subject to regulation under Section 404 of the CWA.
