

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area addressed in this form contains approximately 11.13 acre tract located off of Farrow Parkway between Powell Lane and Nash Blvd, east of U.S Highway 17 in the city of Myrtle Beach, Horry County, South Carolina. The project area was determined to consist entirely of uplands. Aerial photographs depict the project area as being forested uplands. The USGS topographic survey information depicts the project area as forested uplands and is void of any symbols that would typically represent a water of the United States. The NWI depicts freshwater forested/shrub wetland (PF04/1Bd) and upland planted pine (U42P). A previous determination (SAC-2011-00591-3) evaluated the project area and determined it consisted entirely of uplands. Due to the consistency in the depiction of uplands throughout the USGS topographic information, NWI maps, aerial photos and previous determination the project was determined to be void of any aquatic resources.
