**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A desktop review was conducted on October 24, 2016. The NWI map depicts a palustrine forested wetland on site, however, the data sheets and photographs submitted by the applicant depict this area to consist of non-hydric soils. The submitted survey plat, data forms, NWI map, USDA soil survey map, aerial photographs, and project photographs were reviewed for accuracy and completeness. After reviewing the above mentioned information, it was determined that the project consists entirely of uplands. According to soil survey information, the project area consists entirely of non-hydric soils (Noboco), and is mapped as uplands (U42P) on NWI maps.
