shown on a supplemental sketch. The ditch is approximately 2-3 feet deep, 6 feet wide feet wide and 300 feet long. It does not exhibit an OHWM and was filled with leaves and vegetation. It did not have any visible flow on the date of the site visit. This ditch originates in uplands. It was determined the ditch was excavated from uplands and drains only uplands. This ditch was determined to be non-jurisdictional to the point where it reaches the critical area and then becomes TNW.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This is based on based on a site visit on December 15, 2015 as well as review of available information including USGS Quad maps, USDA NRCS Soil Survey information, National Wetland Inventory data, aerial photographs, and information submitted by the consultant.
