acres) and Wetland 2 (0.15 acres) are both depressional, isolated wetland that sits 1-2 feet lower than the surrounding uplands. Both wetlands continue offsite slightly but do not appear to continue any further. No ditches or swales were observed abutting them. They both receive surface runoff from the surrounding uplands and development, but have no outlet except through evapotranspiration. They do not have a physical hydrologic outlet and no apparent ecological connectivity with other water features, including any waters of the U.S., and no apparent connection to interstate or foreign commerce. Therefore, wetlands 1 and 2 were determined to be a non-jurisdictional, isolated wetlands and therefore not subject to regulation under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
