A bridge on S.C. Highway 544 allows for an unobstructed chemical, physical, and biological connection between the on-site wetlands and the Waccamaw River (a TNW). This depiction is supported by aerial photograph, NWIs, Horry County LiDAR, and USGS topographic maps.**

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

under normal climatic conditions. Flow was observed during the site visit. The pRPW is bordered on both sides by wetlands that were saturated to the surface, suggesting that the RPW is at least partially fed by ground water. The stream geomorphic indicators of perennial flow were a sinuous channel within the bed and bank which had a firm sandy bottom clear of vegetation and debris. Hydrologic indicators observed were an even distribution of substrates in the stream channel and leaves being continually washed downstream.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetlands on site are floodplain wetlands associated with a pRPW. Wetlands are separated from uplands by a steep topographic break. Both the wetlands and the pRPW continue off site to the west (under S.C. Highway 544 via bridge) and discharge directly into the Waccamaw River (a TNW). Soils within wetlands on site were low chroma and value and were saturated to the surface. Ponds were determined to have been excavated wholly out of uplands. .**
