excavated out of uplands and to drain only uplands. This feature is located adjacent to wetland 1 and was observed in the field during a site visit conducted on August 21, 2014 in association with Approved JD SAC 2014-00685.

Summarize rationale supporting determination: Report No. 7 of the U.S. Army Corps of Engineers 1977 Navigability Study:
The Corps presently classifies the Waccamaw River as a "Navigable water of the U.S." between its mouth at Winyah
Bay near Georgetown South Carolina to Lake Waccamaw (R.M. 140). In addition, the Waccamaw River is subject to
the ebb and flow of the tide at this location.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": Wetlands continue off-site and are part of a larger contiguos system (wetlands and impoundment) that discharges directly into the Waccamaw River. This connection was first documented in Approved JD SAC 2014-00685 and is suppurted by USGS topographic maps, NWIs, and aerial photographs.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 26.62 acre tract that was determined to contain 1.37 acres of jurisdictional freshwater wetlands that are adjacent to the Waccamaw River, a TNW. Wetlands were originally delineated and verified on site as part of a larger tract (Approved JD SAC 2014-00685 issued in September of 2014). The wetland delineation is supported by the previous JD, USGS topographic maps, NWIs, and Horry County LiDAR with Hill shade over lay. Wetlands on site are low lying finger wetlands that continue off site to the Northwest and drain into the Waccamw River.
