**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**Jurisdictional tributary 2. Jurisdictional Tributary 1 had a bed and bank and OHWM present during the site visit. In addition, the feature had observable flow and appeared to exhibit perennial flow characteristics such as sediment sorting, bank cutting, etc. and therefore the flow regime was determined to be perennial. Jurisdictional Tributary 2 flows 340 linear feet onsite, where it continues offsite for 6 miles, until it ultimately discharges into the Ashley River, a TNW. Jurisdictional Tributary 2 had a bed and bank and OHWM present during the site visit. In addition the feature is a named USGS blue-line stream (Rumphs Hill Creek) and it exhibited perennial flow and perennial flow characteristics, as described above, during the site visit. .**
