connections to other waters onsite. These 2 wetlands (Non-Jurisdictional Wetlands 1 and 2) are immediately surrounded by upland areas. These 2 wetlands receive runoff from these upland areas, but their only outlet is through evapotranspiration. They do not have either a surface or apparent subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the US and no apparent connection to interstate or foreign commerce. Therefore, these wetlands were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

CWA, nor Section 10 of the RHA. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
